Privacy Statement EP TALENT SEARCH

This document serves as the privacy statement for Mrs. E. Putz, who conducts business as EP Talent Search. EP Talent Search is registered with the Chamber of Commerce under the number 58358455 and is located at Sint Jorisplein 1E, 7061CN, in Terborg.

This document outlines the procedures EP Talent Search employs in managing your personal data. We take great care in processing your personal data with the highest regard for your privacy.

Acquisition of Personal Data

When utilising EP Talent Search's services, you may either directly provide us with personal data or it may be gathered in relation to the contractual agreement. 'Personal data' refers to any information about a identified or identifiable natural person.

Categories of Personal Data

EP Talent Search processes the following types of personal data:

- 1. Contact details, including name and address;
- 2. Geographic information, such as postcodes with house numbers;

- 6. Additional personal data you provide.

Purpose of Processing

EP Talent Search processes personal data with the objectives of:

Legal Grounds for Processing
